- Maintain a good understanding of key issues impacting the legal profession in Wales by engaging with members and colleagues across the Law Society
- Promote awareness of specific Welsh members issues within the Law Society, utilising these to develop the member offer and engagement plans
- Use member behavioural trends, insights, and information to plan, personalise and tailor the member experience offer to key membership groups
- Regularly review and report the progress of all engagement activity against work plans and objectives set by the Head of Wales
- Work collaboratively with colleagues within the Wales office and across the Law Society on a broad range of issues to include events management, communications and social media activity
- Prepare and present high-quality papers to the Wales Board and other Boards and Committees of the Law Society as required
- Effectively participate in discussion forums which assist to identify the business needs of solicitors in Wales
- Maximise the profile of the work and achievements of the Wales Office both internally and externally by contributing stories and other content to the relevant communications team
- Develop and maintain effective relationships with all active local law societies across Wales, including attending all local Law Society meetings either in person or online, including re-establishing local law societies where they have become moribund
- Develop and grow strong relationships with junior lawyers and university law societies across Wales
- Utilise the database of member firms in Wales to ensure effective and meaningful contact is made over the next 24 months
